# 3/9/15 To approve minutes of the meeting held on 6<sup>th</sup> August 2015 (previously circulated)

After a small alteration to 8c the minutes were approved as a true and accurate record and duly signed by the chairman.

## 4/9/15 Brief Report from Ward Councillor

Cllr Johnson advised that the formal response from the Inspector of the Core Strategy is expected back by 18<sup>th</sup> September and should be adopted 16<sup>th</sup> October.

Cllr Johnson was asked to revisit the "settlement / parish" terminology to meet housing numbers in the Core Strategy as discussed at previous meetings. Herefordshire Council's consultation on the 2016/17 budget closes on 12<sup>th</sup> October, the responses so far are very mixed - city v rural.

The Local Enterprise Partnership have an opportunity for another round of bidding for enterprise zones. Whether they do a joint bid with Shropshire for multi and individual sites or a single bid is yet to be decided. A letter is to be sent to DCLG with an expression of intent for a county deal plan that devolution could work with infrastructure, transport and shared LEC partner skills and combined budgets with Wye Valley Trust, Clinical Commissioning Group and Together Mental Trust. The basis of the deal will be put together for submission to DCLG by the end of October.

Cllr Johnson was questioned on the delays and problems reaching rural areas with the Fastershire broadband project. Airband are a company offering an alternative.

## 6/9/15 Update on Proposed Developments for Bosbury Village

A decision is to be reached by representation only and is expected end of Sept / early October.

It was suggested that links are incorporated to include all neighbouring villages and Ledbury town websites. It was AGREED to offer Mrs Ferrier the contract which would be reviewed annually in May.
