The chairman welcomed everyone to the meeting and congratulated Ward Cllr Johnson on being re-appointed Hope End Ward Cllr and Leader of Herefordshire Council.

The minutes were approved as a true and accurate record and duly signed by the chairman.

4/7/15 Brief Report from Ward Councillor

Cllr Johnson advised that the block grant received by Herefordshire Council from central government is likely to reduce to £0 by 2020. Therefore Herefordshire Council is having to make savings in their budget - £33m last year, £28m in 2015/16 and £22m in 2016/17. Health, Education and Defence budgets are ring-fenced by central government. Herefordshire Council are inviting the public to comment on where they feel reductions could be made. Suggestions are are £1.4m reduction in cultural studies (eg libraries and museums),cut back on grass cutting, reduce council tax support schemes, increase car park charges, increase crematorium charges, asset disposal of £1.6m. Councillors were invited to attend a meeting on 22nd July at Shire Hall Hereford where the budget proposals would be discussed. Cllr Johnson will forward the clerk a copy of the budget proposal consultations.

Herefordshire Council are looking at various ways to save money such as combining with other local authorities, selling off small holdings and business opportunities to the private sector. It is not yet known whether council tax will rise by more than 2%.

The Core Strategy is still with the inspector. A report is expected any day, no changes have been asked for to date. It is hoped the Core Strategy will be

5/7/15 Open Forum for Local Residents to raise matters relevant to the Parish Council

A local resident asked for white lining to be renewed on the A and B roads. The clerk is to ask Festival Housing to take away the grass cuttings when mowing the play area. The broadband speed in Coddington is very poor, can the parish council apply pressure on relevant bodies. The clerk had received a complaint about HGV's in Coddington causing damage to verges and the possibility of damaging a mains gas valve. Cllr Lovering offered Coddington Court for a fundraising lunch.
