The traffic calming threshold gates have been installed at the Cradley end of the village. Cllrs Joyce-Townsend and Hayes were thanked for their time and work. The cost of the threshold gates at both ends of the village work out at about £1.15 per resident and thought to be excellent value for money. The footpath officer will send a list to the clerk for forwarding to the Locality Steward for checking and enforcing.
