Update from Parish Clerk

- Met with Neil James, locality officer, to work through each of the highways/footpath issues to make progress and gather updates.
- I have responded to queries regarding fixed assets and PWB loan from the external auditors Grant Thornton.
- The application for a grant to fund the transfer of the website to a cheaper solution and for the 1st years maintenance has been approved and I have made contact with Eyelid Productions (website company) to schedule the work and my training.
- I have made contact with the Buchanan trust and Peter Buchanan is attending the September meeting.
- I have liaised with the Land Registry regarding the land at Forge Bank which the Parish Council were trying to register. The application has been rejected as incorrect and insufficient documents and information was submitted. I have now submitted a land search and located the original deeds at Masefield solicitors. The application to register the land can then be submitted.
- I have contacted RLB lawyers who are the Church Commissioners representatives to start enquiries regarding the play area covenant on the Forge Bank land and whether there is a possibility this could be removed.
