- 1.0 To Accept any Apologies for Absence and Note the Reason Apologies were RECEIVED and ACCEPTED from Cllr Tim Newsholme – Work
- 2.0 To Record any Declarations of Interest and Requests for Dispensations
  Cllr. Liz Cooke declared a NPI against item 5.4 and signed the Register of Interest book.

  The minutes were APPROVED and duly signed by the Chair.

- 5.0 To consider any new Planning Applications received for determination by Herefordshire Council.
  - 5.1 192710 Land at Hollymount, Bosbury, Herefordshire, Proposed refurbishment and conversion of existing guest accommodation in barns to provide 2 no. holiday lets.

It was RESOLVED to support this application with the following conditions:

- The entrance is well signposted on both sides of the highway.
- Due regard is given to the lighting of the driveway so that there is no light pollution.
- 5.2 193024 Upleadon Farm, Munsley, Ledbury, Herefordshire HR8 2SL Proposed construction of equine facilities including indoor arena, outdoor arena, American barn, horse walker and associated works.

It was RESOLVED to object to this application for the following reasons:

- The application is of a disproportionate size and overbearing nature.
- All lighting used will be clearly seen from the Malvern Hills AONB as well as other areas of the surrounding countryside.
- There is no quantification of the loss of trees in the application.
- There is no mention of change of use from agricultural to equine in the application.
- The additional traffic generation caused by horse boxes and equine vehicles would be unsuitable for the small highway.
- There are factual errors in the design statement.
